Analysis: Are Asset Managers Blindly Following ISS on ESG?

EXECUTIVE SUMMARY

This paper presents findings regarding certain large asset managers who have voted at least 75% of the time in line with "for" recommendations by Institutional Shareholder Services (ISS) on climate-related shareholder proposals. This is a striking finding because this level of support is more than *double* the overall market support of 37% for these proposals and suggests that the asset managers identified in this paper are failing to conduct their own independent analyses into the merits of these proposals and instead are following the lead of ISS or another aligned third party.

Further, the fact that ISS consistently supports climate-related proposals that, on average, received only 37% support (and only 17% of which received majority support) also directly refutes ISS's claim that its benchmark policy is "centrist" on ESG issues. Instead, these statistics show that ISS has adopted an activist policy position as to these types of shareholder proposals. The table below illustrates the key findings of the research.

Split votes were counted as "against" votes for purposes of this table. This is a conservative assumption that lowers the percentages for the asset managers, even though a "split" vote could consist of all but one of an asset managers' funds voting "for" a proposal.

METHODOLOGY

Consumers' Research reviewed the overall support of ISS under its benchmark voting policy, not any specialty policy. The current ISS benchmark policy is available here. https://www.issgovernance.com/file/policy/active/americas/US-Voting-Guidelines.pdf?v=1.

It also focused on shareholder resolutions selected by Ceres for inclusion in its Climate and Sustainability Shareholder Resolutions Database. https://engagements.ceres.org/. The Ceres database is a reasonable sample of environmental proposals to study. Ceres self-identifies as "a nonprofit advocacy organization working to accelerate the transition to a cleaner, more just, and sustainable economy." https://www.ceres.org/about. Ceres also noted its leverage. stating that its investors reached a "[r]ecord number of negotiated agreements" in exchange for resolution withdrawals, including agreements by electric utilities "to set targets for reducing Scope 3 greenhouse gas emissions." https://www.reducing Scope 3 greenhouse gas emissions." ceres.org/news-center/press-releases/record-number-negotiated-agreements-between-investors-and-companies-2022. Ceres is also one of the founding networks of Climate Action 100+. which was a prominent activist organization in the period for the votes examined. https://www.climateaction100.org/about/. Ceres's database has existed since at least May 2018, and it contains flagged votes going back to 2009. https://web.archive. org/web/20180521025602/https://engagements.ceres.org/. It, therefore, is a reasonable sample of proposals for public companies that environmental activists support.

STEPS TO OBTAIN CERES-FLAGGED VOTES WHERE ISS RECOMMENDED "FOR" FOR 2020-2023

This review focused on four proxy seasons: 2020-2023. This time period was selected to provide a sufficiently large sample size, and BlackRock joined CA100+ in January 2020, showing Ceres and its aligned activists had gained substantial leverage on climate-change issues starting around this time. The first step was to narrow the Ceres database to shareholder proposals, reflected in the "Resolution" Type in the database. The second step was to narrow down the proposals for each year to those where a shareholder vote occurred, which is shown by a status of "vote" on the database, as opposed to other statuses such as "withdrawn: commitment" or "omitted." This resulted in 362 proposals for which ISS could potentially recommend a "for" vote (as shown in the third column of the table below).

It should be noted that a larger number of resolutions were flagged in 2023 and 2022 than in 2021 and 2020. This may reflect the Ceres database taking a broader view of which proposals to flag in more recent years. ISS's percentage support over the years remains relatively constant, with only a recent drop shown in 2023.

To determine if ISS recommended "for" an environmental proposal, Consumers' Research used synthetically generated assessments from the Insightia platform (aka Diligent Market Intelligence) of whether ISS recommended voting in favor of a proposal under its benchmark policy. This is the same data used by the Committee to Unleash Prosperity in a 2023 report entitled *Politics* over Pensions, at p. 9. https://committee-tounleashprosperity.com/wp-content/uploads/2023/05/PensionPolitics_Report-1.pdf

Using this synthetic data, the ISS benchmark policy recommended "for" votes for **approximately 56.4%** (204/362) of such proposals over this period.

ISS's 56.4% support contrasts with findings from a recent study of "environmental, social, and related sustainable governance" proposals. https://corpgov.law.harvard.edu/2024/04/24/environmental-social-policy-issues-in-the-2024-u-s-proxy-season/
That study found that overall market support for all such proposals (not just those flagged by Ceres) peaked at 33.3% in 2021 and was down to 21.5% in 2023. While the Ceres-flagged proposals may be selected for inclusion in Ceres's database on the grounds that they are more meritorious than the average ESG proposal, ISS's 56.4% overall support for such proposals is still a significantly higher rate of support than the market average even in 2021, the highest year for such support.

In sum, ISS's benchmark policy appears to have supported Ceres-flagged climate-change-related proposals at a relatively high rate of 56.6% compared to overall market support for ESG proposals of 21.5-33.3%. It should be noted that this is not a straight apples-to-apples comparison.

FURTHER STEP TO OBTAIN VOTES WHERE ISS RECOMMENDED "FOR" OVER MANAGEMENT'S OPPOSITION IN 2020-2023

To narrow the proposals to those that ISS recommended "for" and that were opposed by the target company's management, the proxy statements for the 204 votes identified in the previous table were individually reviewed for management's position on the proposal. This removed 12 of the 204 total

proposals (5.9%), leaving 192. The 12 that were removed were either supported by management or management took no position on the proposal. Removing these 12 provides a better baseline for comparing asset manager support for such proposals to overall market support, when company management opposes the proposal.

CALCULATION OF OVERALL MARKET SUPPORT FOR THE 192 ISS "FOR" PROPOSALS

This section lists the 192 proposals and shows the overall market support for such proposals. Importantly, the average market support for the 192 proposals was only 37.2%. In addition, only 17.2% (33/192) received majority support, further suggesting that ISS's benchmark recommendations in this area are not reflective of the view of the market but rather are reflective of activist goals to push companies and the market toward supporting net zero.

ASSET MANAGER SUPPORT FOR 192 ISS "FOR" PROPOSALS

Finally, Consumers' Research identified 26 large asset managers that appear to vote with ISS's "for" recommendations on these 192 Ceres-flagged, management-opposed proposals at least 75% of the time and, in some cases, much more often than 75%. This is at least twice as high as the overall market support of 37.2%. This asset manager vote data underlying this analysis was similarly obtained from the Insightia platform (aka Diligent Market Intelligence), but it is also publicly obtainable.

The data table showing the ISS-aligned voting by these asset managers for the 192 proposals is available in Appendix A.
